- ✓ Front chain link fence at park was repaired due to vandalism.
- ✓ Playground equipment was repaired due to vandalism.
- $\checkmark$  Pool staff gate lock was repaired due to vandalism.
- ✓ Landscaper aerated the park field on 9/29/23.
- $\checkmark$  Landscapers removed dead pine tree at entrance.
- ✓ 2-year CD was purchased; \$25,000 @ 5.3%.
- ✓ Labor Day BBQ was a success with around 150 people in attendance.
